OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DISTRICT OF COLUMBIA WHO ARE AT LEAST 18 YEARS OLD AS OF THE DATE OF ENTRY AND ARE NOT PGA PROFESSIONALS (AS DEFINED BY THE RULES OF THE U.S.G.A., SET FORTH IN SECTION 2 BELOW)

By entering this Promotion, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may, at Sponsor’s discretion, result in disqualification. All decisions of the judges regarding this Promotion are final and binding in all respects.

1. **PROMOTION PERIOD.** Promotion begins April 1, 2010 at 12:01 AM ET and ends April 30, 2010 at 11:59 PM ET, when all entries must be received (“Promotion Period”).
2. **ELIGIBILITY.** This sweepstakes (the “Promotion”) is only open to legal residents of the 50 United States and District of Columbia who are at least 18 years old as of the date of entry and are not PGA Professionals (as defined by the rules of the U.S.G.A. described below), except officers, directors, members, and employees of the Sponsor, or any other party associated with the development or administration of this Promotion, and their immediate family (i.e., parents, children, siblings, spouse), and persons residing in the same household, as such individuals. This Promotion is void outside the 50 United States and the District of Columbia, and where prohibited. THE U.S.G.A. defines a “PGA Professional” as one who plays the game as a non-remunerative and non-profit-making sport and who does not receive remuneration for teaching golf or for other activities because of golf skill or reputation.
3. **HOW TO ENTER.** Visit PlayGolfAmerica.com/fft during the Promotion Period and follow the instructions to complete and submit the entry form. All entries become the property of the Sponsor and will not be acknowledged or returned. Limit: One entry per person and per e-mail address during the Promotion Period. All entrant information, including e-mail addresses, is subject to the respective Privacy Policy of the applicable Sponsor.
4. **WINNER SELECTION AND NOTIFICATION.** Winner selection will be conducted by random drawing from all eligible entries on or about May 7, 2010 (the “Drawing Date”). Any potential winner will be notified by mail, email and/or telephone. If a potential winner: (i) cannot be contacted; (ii) does not respond within

five (5) days from the date the Sponsor first tries to notify him/her; (iii) fails to return the Affidavit and Release as specified in Rule 9; (iv) refuses the prize; and/or (v) the prize or prize notification is returned as undeliverable, such potential winner forfeits all rights to win the Promotion or receive the prize, and an alternate potential winner may be selected. (After five (5) such alternate potential winners have been selected without securing an eligible winner, the prize may remain un-awarded.) Upon contacting a potential winner and determining that he/she has met all eligibility requirements of the Promotion, including without limitation the execution of required waivers, publicity and liability releases and disclaimers, such individual will be declared the “winner” of the Promotion.

5. **PRIZE DESCRIPTION.** There will be one (1) Grand Prize Winner and four (4) Runners-Up. The Grand Prize is two (2) round trip economy airline tickets from the major commercial airport nearest winner's primary residence in the US to Wisconsin, one (1) standard hotel room (double-occupancy) for five (5) nights at a hotel to be chosen by Sponsors and two (2) grounds passes to the PGA Championship at Whistling Straits, Kohler, WI August 9 – 15, 2010. The approximate retail value for Sweepstakes Grand Prize is \$4,800, depending on exact itinerary. Actual value may vary based on fluctuations in price for airfare and/or accommodations, and distance between departure and destination. Ground transportation, meals, in-room or other personal charges at lodging (e.g., mini-bar, movies), telephone calls, gratuities, incidentals, and all other expenses are not included. Winner and guest must be available to travel to coincide with the 2010 PGA Championship, otherwise winner forfeits the prize and an alternate winner will be chosen. Sponsor will attempt to accommodate winner's preferred itinerary, but all specifics thereof will be at Sponsor's sole discretion. If, in the sole judgment of Sponsor, air travel is not required due to winner's proximity to prize location, ground transportation may be substituted for roundtrip air travel. Unless child of winner, travel companion must be 18 years of age or older as of the date of departure. The Runner-Up prize is one (1) set of custom-fit golf clubs (one (1) driver, irons: 3-PW, two (2) wedges, one (1) fairway wood, one (1) putter). The approximate retail value of the Runner-Up Prize is \$2,600 each.
