

WELCOME TO GOLF MONTH SWEEPSTAKES

Official Sweepstakes Rules

NO PURCHASE NECESSARY.

Sweepstakes begin 5/1/12 and end 5/31/12.

Sweepstakes entrants must be amateur golfers (as defined by the U.S.G.A.).

1. Sweepstakes begins 12:01 AM ET 5/1/12 and ends 11:59 PM ET 5/31/12. Online entries must be received by 11:59 PM ET 5/31/12. To enter participate in Welcome to Golf Month activities with any participating PGA/LPGA Professional. The full list of participating PGA/LPGA Professionals is available PlayGolfAmerica.com/WTG and will be updated regularly. Once you have participated in a instruction activity 1) visit PlayGolfAmerica.com/WTG to complete the entry form and submit it as directed. **Residents of California do not need to take a complimentary instruction activity.** One entry per person. Entries that are lost, late, misdirected, incorrect, garbled, or incompletely received, for any reason, including by reason of hardware, software, browser, or network failure, malfunction, congestion, or incompatibility at Sponsors' servers or elsewhere, will not be eligible. Sponsors, in their sole discretion, reserve the right to disqualify any person tampering with the entry process or the operation of the web site. Use of bots or other automated process to enter is prohibited and may result in disqualification at the sole discretion of Sponsors. Sponsors further reserve the right to cancel, terminate or modify any promotion not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, force majeure or technical failures of any sort. In the event of a dispute, entries will be deemed submitted by the authorized account holder of the email address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet Access Provider, online service provider, or other organization (e.g., business, educational institute) that is responsible for assigning e-mail addresses for the domain associated with the submitted email address.

2. On or about 7/1/12, One (1) potential Grand Prize winner and two (2) potential Runners-Up will be selected in a random drawing from all eligible entries. Potential winners will be notified by e-mail, mail and/or telephone. If any potential winner cannot be contacted, does not respond within five (5) days, or the prize notification is returned as undeliverable, such potential winner forfeits all rights to any prize, and an alternate winner may be selected. By participating in the Sweepstakes, you agree to be bound by all decisions and rules of Sponsors, which are final and binding in all respects.

3. Sweepstakes Grand Prize: two (2) round-trip economy airline tickets from a major commercial airport nearest winner's primary residence in the U.S. to Palm Beach International Airport (West Palm Beach, FL), one (1) standard hotel room (double-occupancy) for two (2) nights, attendance for two (2) for two and a half days at the PGA Golf School at the PGA Center for Golf Learning and Performance in Port St. Lucie, FL, taught by a PGA/LPGA Professional. Approximate retail value of the Grand Prize is \$2,100, depending on exact itinerary. Actual value may vary based on fluctuations in price for airfare and/or accommodations, and distance between departure and destination. Ground transportation, airline baggage fees, meals, in-room or other personal charges at lodging (e.g., mini-bar, movies), telephone calls, gratuities, incidentals, and all other expenses are not included. Winner and travel companion must be available to travel on the same itinerary. Trip must be booked by August 1, 2012 and completed by December 31, 2012, and may be subject to certain other restrictions, including without limitation blackout dates.
