PGA FREE LESSON MONTH CONTEST AND SWEEPSTAKES RULES

NO PURCHASE NECESSARY

Contest and Sweepstakes begin 5/1/08 and end 5/31/08.

1. PGA Professionals may enter the Contest and amateurs may enter the Sweepstakes.

To enter the Sweepstakes, amateurs must first complete a PGA Free Lesson Card (FLC). Obtain an FLC by sending a self-addressed, stamped envelope (WA & VT residents need not affix return postage) to PGA Free Lesson Month Contest & Sweepstakes Entry Form, c/o Maureen Coleman Golf Digest, 750 Third Avenue, 3rd Floor, NY, NY 10017 or by visiting www.PlayGolfAmerica.com to download and print an official FLC. Next, amateurs must schedule and take a 10-minute Free Lesson with any participating PGA Professional. A partial listing of participating PGA Professionals appears in the May 2008 issue of Golf Digest; the full list will be available at PlayGolfAmerica.com and will be updated regularly. Have the PGA Professional complete and sign your FLC. Then have the PGA Professional send in your FLC, or add postage and mail yourself. Residents of California do not need to take the free 10-minute lesson, nor have their entries completed or signed by a PGA Professional.

To enter the Contest, PGA Professionals may return, in the envelope provided, all FLCs that he or she collects.

Sponsors are not responsible for lost, late, damaged, illegible, incomplete, incorrect, misdirected or postage-due mail/entries. Amateurs and Professionals may only enter once. Completed entries may not be mechanically reproduced.

Entries must be postmarked by 5/31/08 and received by 6/15/08.

2. One (1) potential Grand Prize Sweepstakes winning FLC, naming one Amateur, and One hundred (100) potential Runner-Up Sweepstakes winning FLCs, naming 100 different Amateurs, will be selected in a random drawing on or around 7/1/08 from all eligible entries. Potential winners will be notified by mail and/or telephone. The PGA Professional who has given the most free lessons and sent in the most FLCs will be named the potential Contest Grand Prize winner. In the event of a tie, the winner will be chosen at random from among the PGA Professionals who submit the most FLCs. If any potential winner cannot be contacted, does not respond within five (5) days, or the prize notification is returned as undeliverable, such potential winner forfeits all rights to any prize, and an alternate winner may be selected.
