Once you have taken the 10-minute Free Lesson either 1) visit www.playgolfamerica.com/FLM to complete the entry form and submit it as directed or 2) have the PGA/LPGA Professional complete and sign the Free Lesson Card ("FLC") available in the May 2010 newsstand issue of *Golf Digest* Magazine and mail it to the address printed on the card.
