## 2 VOLUNTEER RELEASE OF LIABILITY & BACKGROUND CHECK AUTHORIZATION

IN CONNECTION with my activities or the activities of my child as a volunteer for the 2008 Senior PGA Championship ("the Championship") to be held at Oak Hill Country Club in Rochester, New York, I agree and understand that the presence of me or my child at the Championship and any volunteer work or services performed by me or my child for the Championship, Oak Hill Country Club, the PGA Tournament Corporation, Inc., The PGA of America, their respective affiliates, subsidiaries, employees, agents, and representatives (collectively referred to as "the Indemnified Parties") may expose me or my child volunteer to both known and unanticipated risks of injury.

I FURTHER UNDERSTAND that the Indemnified Parties will not maintain insurance which will cover me or my child for either personal injury, property damage, or medical expenses, and I accept full responsibility for the costs of treatment for any injury or damages suffered while participating as a volunteer in connection with the Championship.

I have fully informed myself of the contents of this release by reading it before signing it and agree to be bound by the terms set forth herein in consideration for performing volunteer services. Also, by my signature below, I hereby authorize the PGA Tournament Corporation, Inc., Oak Hill Country Club, and/or local/state law enforcement to complete a background check on me with the appropriate authorities.
